

AMENDING AGREEMENT

THIS AMENDING AGREEMENT (the "Agreement") is made as of the 1st day of July, 2010

B E T W E E N:

NORTH EAST LOCAL HEALTH INTEGRATION NETWORK (the "LHIN")

AND

EXTENDICARE NORTHEASTERN ONTARIO INC. (the "HSP")

WHEREAS the LHIN and the HSP (together the "Parties") entered into a service accountability agreement that took effect July 1, 2010 (the "L-SAA");

AND WHEREAS the Parties have since recognized that the legal name of the HSP is incorrectly identified in the L-SAA;

NOW THEREFORE in consideration of mutual promises and agreements contained in this Agreement and other good and valuable consideration, the parties agree as follows


- 1.0 Definitions.** Except as otherwise defined in this Agreement, all terms shall have the meaning ascribed to them in the L-SAA.
- 2.0 Amendments.**
 - 2.1 Agreed Amendments.** The Parties agree that the L-SAA shall be amended as set out in this Article 2.
 - 2.2 Name of the HSP.** The name of the HSP set out at the top of the second page of the L-SAA and in Article 13.1 on page 21 of the L-SAA and at the bottom of page 25 of the L-SAA and in Schedule A, Section A-1 on page 27 of the L-SAA shall be deleted and replaced with "Extendicare Northeastern Ontario Inc."
- 3.0 Effective Date.** The Parties agree that the amendments set out in Article 2 shall take effect as of July 1, 2010. All other terms of the L-SAA and the schedules appended to the L-SAA shall remain in full force and effect.
- 4.0 Governing Law.** This Agreement and the rights, obligations and relations of the Parties will be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.


5.0 Counterparts. This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.

6.0 Entire Agreement. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter contained in this Agreement and supersedes all prior oral or written representations and agreements.




